His previous affiliations include that as President of the National Association of Insurance Commissioners, Co-Founder and First Chairman of the International Association of Insurance Commissioners, member of the Board of Regents of Loras College in Dubuque, Iowa, and Adjunct Professor of Law at Pace University Law School from 1998 to 2004. He is a frequent public speaker.

Mr. Walsh earned a Master's degree in Professional Studies, Industrial and Labor Relations from Cornell University, a Juris Doctor degree from the University of Wisconsin, a Master's degree in Business Administration from Alaska Pacific University, and a Bachelor's degree in Psychology from Loras College. He is currently working toward a Ph.D. from the University College Dublin.
